Anastasia Angelopoulou is a graduate of the School of Theology at the Faculty of Theology in the Aristotle University of Thessaloniki. She holds a Master's Degree from the same School, about the relationships between Jews and Greeks, according to Josephus. She, also, holds a PhD from the School of Social Theology and the Study of Religion at the National and Kapodistrian University of Athens under the title: «Religious propagandas at the metropolitanates and bishoprics of the vilaiet of Thessaloniki, 1980-1912. The issue of the disputed holy places of worship at the local Greek orthodox communities».

She worked on various administrative positions, as well as research projects and committees at the Aristotle University of Thessaloniki. Since 2019 she is working as Specialized Technical Laboratory Staff at the School of Social Theology and Christian Culture in the Aristotle University of Thessaloniki and since 2021 as Laboratory Teaching Staff at the same School.

She's a Member-Scientific Consultant of a programme for the emigrants Greeks abroad (Ecumenical Hellenism). It is a non governmental organization in Athens (3<sup>rd</sup> September 144 street).
